#### **Limitations of Use**

- Usage, maintenance and storage as per manufacturer's instructions.
- The User Information has been assessed in the English language only. It is the responsibility of the Manufacturer / Authorised Representative to ensure the content and accuracy of the User Information presented in other languages.
- The garments above meet the requirements of EN 1149-1:2006 and EN 1149-5:2008 for electrostatic dissipative
  protective clothing, however they may not be suitable for use in explosive atmospheres, as indicated by the
  manufacturer's user information.
- The material used in the construction of the garment was tested against 4.8 of EN 14325:2004 (bursting resistance) instead of clause 4.9 (tensile strength) as required by EN 14605. In addition, the diameter of the test specimen used was 30mm instead of the specified 50mm, which is likely to lead to a higher result than would otherwise have been achieved. However the result obtained was 228.0 kPa, which is considerably greater than the minimum requirement of 40 kPa in EN 14325. In the opinion of BTTG Testing & Certification, the material used in the construction of the garment would easily meet the requirements of clause 4.9 (tensile strength) and clause 4.8 (bursting resistance) of EN 14325:2004.
